## Social Security Address Trace Report

- Confirms the year that the social security number was issued
- State of issue
- Par aliases and possible maiden names
- Checks date of birth with social security records

## 7 Year Unlimited County Search (1 name)

- Ideal search when looking for the most up-to-date criminal information
